1. Opening and Prayer

P Millan submitted a un audited financial report. The meeting have taken note of the report. Kobus Botha raised a point that we must endeavour to have the report audited and have proposed that new Auditors must be appointed.

A motion was passed to approach and appoint BGR Broodryk Kotzé Chartered Accountants to act as auditors of the SAHRSA.

Kobus Botha has offered assistance in drawing up full auditable statements for the periods back dated to the last audited statements on record.

Maximum age for juniors

Juniors classification will be on a annual basis set based on the age of the Junior on the first day of January every year. The age of Juniors will be raised to be not older than 17 years of age as on the first day of January of the current year.

Penalties for late Membership dues No penalty to be prescribed, viii. members to pay prescribed annual fee and a re registration fee for registration after the last day of March. Registration fee is currently set at R100.

ix. **Updates to Rules**

Rules that catered for a minimum of 2 Freehand ranges, no targets closer that 60m, time adjustment on double gong ranges, range vetting, chamber flags and Fumble ranges must be written into the regulations.

Wim Joubert stated that setting fumbling areas must not be compulsory and rather time should be awarded to the competitors on the shooting line to make the necessary adjustments to their equipment. This should include setting of parallax from a standing position.

Proposed Conrad de Does Motion passed by the attendees

Range inspection х.

A discussion regarding range inspection was held and it was agreed that ranges will be inspected by 3 senior members for safety and standards.

These inspections will be done before the commencement of the competition and preferably by members not competing from different provinces if available. If a range is deemed to be un safe the organisers must accordingly make changes mitigating the risk before the commencement of the tournament. The discussion also included mention on fumbling areas.

Proposal was made to have these members entry fee refunded as honorarium for this duty.

Proposed A Roets, seconded P Millan Motion passed

SA Hunters and SAHRSA xi.

Piet Breedt explained to the gathering about the problems that exist between SAHGCA and SAHRSA, given that SAHGCA are seeking to award national (Protea) colours to for Sport Rifle Shooting, which they claim is a different discipline to Veldskiet, when in fact it is not. Piet expressed the need to protect our rights to confer Protea colours, and sought permission from the AGM and EXCO to carry on the defence of our discipline.

It was so agreed by the floor.

223 class to accommodate Semi Auto Rifles. xii.

P Millan proposed that the 223 class be allowed to accommodate semi auto type rifles. This was not supported but J Farnham acceded to the request that each province be allowed to run event for semi auto type 223 rifles shoots as they see fit. The use of semi auto type rifles will not qualify for the 223 rankings.
